

INVITATION TO BID

Invitation to Bid for the Pipeline Installation Project Using Horizontal Directional Drilling (HDD) Method at Provincial Road, Brgy. Bunducan & Mc Arthur Highway, Brgy. Wakas, Bocaue, Bulacan.

1. The **Bocaue Water District (BWD)**, through its corporate budget for 2020 and through its loan from **Local Water Utilities Administration (LWUA)** intends to apply the sum of **Three Million Four Hundred Seventy nine Thousand two hundred Fifty Pesos (P 3,479,250.00)** being the Approved Budget for the Contract (ABC) for the contract for the **Pipeline Installation Project Using Horizontal Directional Drilling (HDD) Method at Provincial Road, Brgy. Bunducan & Mc Arthur Highway, Brgy. Wakas, Bocaue, Bulacan.** Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Bocaue Water District (BWD)** now invites interested bidders for the **Pipeline Installation Project Using Horizontal Directional Drilling (HDD) Method at Provincial Road, Brgy. Bunducan & Mc Arthur Highway, Brgy. Wakas, Bocaue, Bulacan.** Completion of the Works is required **thirty (30) calendar days from the effective date of contract.** Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project with an amount of at least fifty percent (50%) of the Approved Budget for the Contract (ABC). The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II .Instruction to Bidders (**ITB**).

TERMS OF PAYMENT:

Payment shall be made upon request and shall be based on the Progress Payment Report submitted by the Contractor. Full Payment shall be made after completion and acceptance of the work as indicated in the Contract.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulation (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act “.

4. Interested bidders may obtain further information from **Bocaue Water District (BWD) Office** and inspect the Bidding Documents at the address given below from 8:00 am to 3:00 pm. starting **October 06, 2020.**

5. A complete set of Bidding Documents may be purchased by interested bidders from **Bocaue Water District’s Office located at 130 Gov. F Halili Ave. Ext. , Binang II, Bocaue, Bulacan** and upon payment of the Bidding Documents’ fee in the amount of **Five Thousand Pesos (P 5,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the deadline for the submission of their bids.

6. The **Bocaue Water District (BWD)** will hold a Pre-Bid Conference on **October 19, 2020 at 9:00 a.m.** at **Bocaue Water District (BWD) Office** which shall be open to prospective bidders, but attendance shall not be mandatory.

7. Bids must be delivered to the address below on or before **November 10, 2020 at 1:00 pm** at Bocaue Water District (**BWD**) **Office located at 130 Gov. F Halili Ave., Binang II, Bocaue, Bulacan.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids must be opened on **November 10,2020 at 2:00 pm** in the presence of the bidders representative who choose to attend at the address below. Late bids shall not be accepted.

8. All particulars relative to the submission of Bids, Bids Security, Performance Security, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the provisions of R.A. 9184 and its IRR.

9. The Head of the Procuring Entity (HOPE) reserves the right to reject any and all bids, declare a failure of bidding or not award the contract in the situations enumerated in Section 41 (Reservation Clause) of R.A.9184
